The role

This is a hybrid post which involves both facilitation of the Mathematical Institute's industrialfacing activities and postdoctoral-level research. The post-holder will be expected to spend at least 50% of their time building and maintaining relationships between the Mathematical Institute and its industrial partners. This will involve being the first port of call for industrialists and academics who wish to nurture collaborations, coordinating and organising a series of industrial workshops, proactively soliciting and helping develop project descriptions for research projects by researchers at all levels, and coordinating skills and other training courses offered by our industrial partners.

In addition, the post-holder will be expected to undertake high-quality independent research at the interface between mathematics and industry.

The post-holder will report to Professors Chris Breward and Colin Please on a day to day basis, with a professional reporting line through to the Head of Research Facilitation.

Responsibilities

The post-holder will be responsible for:

Strategy:

- Developing the Mathematical Institute's industrial engagement strategy in consultation with appropriate colleagues
- Working with minimal oversight to implement the Mathematical Institute's industrial engagement strategy
- Writing management reports on the Mathematical Institute's industrial activities, including collecting, collating, analysing and reporting company feedback

Development:

- Representing the Mathematical Institute in early-stage contact with industry
- Expanding the portfolio of companies involved with the Mathematical Institute through visits, advertising etc.
- Organising and promoting workshops with Industry, including writing technical reports where necessary
- Working with Companies to identify and set up suitable problems for exploitation as research projects for researchers of all levels
- Coordinating skills and other training courses led by industrial partners

Maintenance:

• Being the principal point of contact for interactions between the Mathematical Institute and its industrial partners

Administration:

- Setting up, developing and maintaining administrative systems for recording details of the Mathematical Institute's engagement with industry, especially concerning impact
- Providing advice and guidance to students and academics on industrial matters
- Writing publicity material and brochures to promote the Mathematical Institute's activities to industry

Research:

- Undertaking original independent research of a high academic standard
- Disseminating their results via conference presentations and journal publications
- Managing their own academic and administrative activities
- Assisting in the supervision of student projects and the development of student research skills
- Participating in, and contributing to, the life of the department

Pre-employment screening

Essential

The successful applicant will:

• have, or be close to completing, a PhD in mathematics or a related discipline.

In addition, applicants will be expected to demonstrate:

- Independence and ability to undertake high-quality research;
- A realisable research plan involving some aspect of industrial mathematics that demonstrates a genuine desire to engage with industry;
- Excellent organisation skills;
- Excellent interpersonal skills, including written and verbal communication skills;
- Fantastic attention to detail, both in their own work and in proofreading of other people's work;
- Ability to work using own initiative and as part of a team;
- Self-motivated, with the ability to manage time effectively.

Desirable

- Experience of working at the interface between academia and industry
- Proven IT Skills in Word, Excel, PowerPoint
